"Is Democracy Dying?" **Cheesman Unit Discussion and Dialogue**

At its 2016 National Convention, the League of Women Voters US began a "Making Democracy Work" Campaign that has been the credo for our local programming and activities. So when Sue Stark brought to our attention that the entire October 2018 issue of The Atlantic Magazine was devoted to addressing the question "Is Democracy Dying?," the Cheesman unit decided to devote a summer meeting to reading, reviewing and responding to its articles. Eighteen Leaguers met at Bobbie Heisterkamp's home to tackle this difficult topic on July 30.

Sue Stark researched and developed a handout that we used as a starting point called "What Is a Democracy: Definitions and Explanations" (available on LWVD website). Bobbie Heisterkamp organized our discussion by assigning each of the nine articles to a Cheesman member, asking that we give a brief synopsis and pose two

questions from the article's main focus. The writers' topics were wide -ranging from:

- whether the US is moving toward the autocracy of an imperial presidency to
- warnings from the possible demise of some European democracies to
- whether technology favors tyranny over democracy
- losing the habit of practicing democracy in our local organizations to
- the rise of factionalism, tribalism and ethical division
- examining how the checks and balances written into the Constitution were meant to cool off the passions

our country's unresolved challenge of racism and the influence of the judicial branch in supporting Rule of

We hope the League goal of increasing voter turnout will prevent extremes at both ends of the spectrum from taking control. We left the gathering more energized and with an even stronger desire to Make Democracy Work for all.

Kick-Off Briefing

Taming Tax Policy: Taking on TABOR in 2019

Monday, September 16 5:30 p.m. Social Time/Announcements 6:00 p.m. Program Begins McCollum Room Montview Presbyterian Church

TABOR (the Taxpayer Bill Of Rights) does way more than just require that Colorado citizens vote on every tax increase. LWVCO understood that when we opposed the measure in 1992. Most voters did not. When voters understand the complex ramifications of the amendment, they are more likely to understand why we need to tame it. The Monday, September 16 briefing will address Colorado Proposition CC (on the ballot in November) and additional possible approaches to dealing with TABOR.

Carol Hedges, Co-Founder and Executive Director of the Colorado Fiscal Institute, has been studying the effects of TABOR on our state and will lead the discussion. Proposition CC would allow the state to retain revenue for transportation and education rather than refund the excess revenue required by TABOR. Hedges will also discuss the ramifications of the Colorado Supreme Court ruling that TABOR could be removed entirely with one vote in 2020. Sally Augden

In 1916, before women even had the right to vote, Emily Griffith opened the first adult public vocational school in the nation providing training in job skills and English. Today, Emily Griffith Technical College (EGTC), formerly Opportunity School, carries on its founder's tradition and inspiration by continuing to provide job skill training in highly sought-after professions and industries and English acquisition skills for non-native speakers. These students generally graduate with little or no debt. Join us for a tour, designed specifically for LWVD, of EGTC faculties and programs.

EGTC has two campuses, each offering different programs. You can take the tour for either one or both of the campuses. The 10:00 a.m. session will provide general information about EGTC and career education and will tour programs including Nursing, Dental Assisting, Culinary, and Cosmetology. The 1:00 p.m. session will tour programs including Automotive, CAD-BIM, Welding, and Water Quality Management. There'll be time for lunch and travel time in between the two sessions. Bringing your own lunch might be the best option.

The tour is free. Transportation is on your own (Carpooling is highly recommended). When we get closer to the date, we will ask you to RSVP.

You Can Help the League of Women Voters of Denver Through Charitable Donations

The League of Women Voters of Denver recently became a 501(c)(3) organization, which means your donations to LWV will now be tax deductible. Over the next several months you will learn about the different types of charitable donations you can make and the Federal tax benefits you may receive from such donations. We recommend that you consult your legal counsel, accountant or financial advisor before making any substantial charitable contribution.

Below is a summary of the types of giving that will be covered:

<u>Cash Donations</u> - The most common and easiest form of donation is cash. The LWVD is able to accept cash, checks or credit cards.

<u>Donation of Publicly Trade Stock or Mutual Funds</u> - You can also donate publicly traded stock and other securities. A donation of stock or other securities generally provides very favorable tax results if you have held the donated stock or other securities for at least one year.

<u>IRA Contributions</u> - If you are 70 1/2 years of age or older, you can make a qualified charitable distribution (QCD) from your IRA and contribute cash, appreciated stock or other assets held in your IRA, without incurring any income tax liability for the IRA or yourself.

<u>Life Insurance</u> - Donors may donate life insurance policies to LWVD or name LWVD as the beneficiary of a life insurance policy.

<u>Donor-Advised Funds; Private Foundations</u> Some donors prefer to spread their donations to charities over several years but wish to deduct the aggregate value of the multi-year donations in the first year. You can achieve both by contributing to a donor-advised fund. You can take a charitable contribution deduction in the year you transfer the gift amount to the donor-advised fund even if you direct the donor-advised fund to distribute the funds to LWVD over a number of years.

<u>Post-death Charitable Contributions</u> - Charitable contributions from your estate may qualify for a charitable contribution deduction for purposes of the estate tax without any limit on the amount of contributions. In other words, you can put LWVD in your will.

We will be giving you more detailed information on these many options over the next several months in the Voter. In the meantime if you would like to speak to someone about charitable giving, please call the office and Fran Coleman will direct you to the right person.

Summary of July Program/Calendar Meeting

We had a lively and productive Program/Calendar meeting on July 23 with 14 Leaguers full of ideas. The enclosed calendar has the results to date of what we decided. We are still working on the details of some events, such as a Drinks & Dialogue evening in September.

We would love to have some members step-up and help with some of the topics we are still considering. Sue Stark needs a couple more members to work on a series of briefings around the issues of what makes up a democracy. Steve Coddington is intent on making a recommendation to City Council on some type of alternative voting method, such as Ranked Choice Voting. We might actually do an official local study on that issue. If so, we need members to help with that.

Denver passed four tax increases last year: parks, college scholarships, mental health, and healthy food. We'd love to have members follow the money as the city implements those changes.

We are starting this League year with an extremely important ballot issue that we must get behind: Proposition CC. (See the article on page 2) As Leaguers, we need to help others understand the importance of supporting Proposition CC.

Girl Scout Gold Award Project

On May 18, I had the privilege of presenting my Girl Scout Gold Award Project to a group of women from the League, including Leaguer Kay Shaw, Gold Award Mentor of Colorado. The Girl Scout Gold

Award is the highest award that a Girl Scout can earn. She must dedicate 80 hours to a sustainable project that has a lasting impact on the community.

For my Gold Award, I decided to help people become more informed voters. While I won't be eligible to vote for two more years, I have noticed that people tend to vote based on a certain single policy issue or on how a candidate presents him or herself. I decided that I wanted to help people become more well-rounded voters.

When I vote for the first time in the next presidential election, I want to understand the whole candidate and all of his/her positions. Ultimately, I think that is what every voter wants.

To achieve this goal, I created a survey for the Denver mayoral candidates. I developed questions that narrowed down the slate of candidates to a single candidate that would best suit the person taking the quiz. The survey showed the people taking it how many policy issues that they need to consider throughout the election, and how their answers could strongly affect the person whom they were told to vote for.

I shared the survey with family and friends before I had the League presentation attendees take it. At the end of the survey, I heard many mumbles in the room, "well I'm not voting for him" or "this isn't

right." Many women were shocked with their results. This was the same response that my Grandpa had when he took the survey. This is because many voters were planning on voting solely based on a specific policy issue such as Executive Order 300 (the urban camping ban) or they were voting either in favor or in opposition to Denver development or they just liked the candidate but didn't understand his or her policies. Policy questions that people did not consider were things such

as should RTD be free to those reliant on public transportation or should there be safe spaces for people to smoke marijuana in public? Since the quiz took all the candidates' positions into account, the best candidate to represent all of the voter's concerns was often different than expected.

I plan to continue working on my survey tool with the help of Dr. Pavielle Haines, a researcher at the Center on American Politics at the University of Denver in hopes that it will be updated by her students to fit the issues and candidates of all future elections and that it with be shared with the League for distribution to make better informed voters.



Board Highlights August 15, 2019 Meeting

- Approved a revised budget due to the elimination of the Education Fund, now that the League of Women Voters of Denver is a 501(c)3 organization
- Reviewed goals for 2019-20 that we set at the retreat in June
- Welcomed Membership Chair Patty Cordova's plan for putting a mentoring program in place
- Reviewed the fall calendar (included in this Voter)
- Discussed the importance of advocating for Proposition CC and getting members and the public out for our Kick-Off meeting Sept. 16, which will help us understand the proposition fully
- Voted to continue to support the National Popular Vote and to actively oppose the 2020 ballot initiative which would remove Colorado's participation
