On a sunny November morning, eight members of the Cheesman Unit had an adventure. Five of us took the RTD bus from Cheesman Park to Union Station and met with three others to board the A-Line train to Denver



International Airport. The bus ride along 12th Avenue had a friendly atmosphere with people greeting the bus driver and thanking him when they departed. Once on the train, we noted the industrial parts of north Denver it flowed through; but then after 40th and Colorado, we were out on the plains and the mountains were beautiful.

Arriving at the DIA station with its array of ponderosa pine beetle-kill trunks (a piece of art) and impressive Westin Hotel architecture above, we were greeted by

John Leavitt, Jonathon Rose and Aaron O'Shea, hotel concierges, who gave us an extensive overview of the hotel (did you know it has a signature scent pumped in through the air system?) and explained how the airport deals with celebrities passing through.

John showed us the free skating rink being assembled on the plaza with its spectacular views. He said Lufthansa crew members often skated here in full uniform on their layovers. The outdoor plaza in the middle of the Westin hotel has become a popular venue for concerts and parties.



Living in Denver without Documentation

Immigration issues continue to be in sharp focus nationally and locally. Over the summer, the Mayor and City Council worked together to pass the Denver Public Safety Enforcement and Priorities Act, which states that "Denver will not engage in immigration enforcement." Colorado leads the states in the number of people living in sanctuary, and Denver was added to the list of "sanctuary cities" threatened with loss of federal funds. Colorado residents without documentation are faced with many challenges to their being able to work, go to school, and raise families here. Confusion about the future of the Deferred Action for Childhood Arrivals (DACA) program has created turmoil for young people who have grown up as Coloradans.

The LWV national immigration position statement supports policies that promote family unification, due process rights and humane treatment. Chris Carson, League's National President, wrote a memo in February stating that "League is opposed to deportation of non-criminal undocumented immigrants" and supports localities that "make a decision not to cooperate with federal deportation and enforcement actions" against these residents.

Our January briefing will provide a panel of knowledgeable speakers on immigration issues: Paul Lopez, Denver City Council member, who worked with the Mayor's office to craft the new ordinance; Jennifer Piper, Interfaith Programming Director of the American Friends Service Committee (Metro Denver Sanctuary Coalition); and a representative of Together Colorado/Juntos Colorado, which utilizes community organizing and education to support human rights.

Becoming 501(c)(3)

(This article was largely reproduced from an article written by Toni Larson explaining the conversion of the LWVCO from a 501(c)(4) to a 501(c)(3))

In the summer of 2016, LWVCO appointed a task force to research combining the IRS-designated 501(c)(3) charitable and 501(c)(4) social welfare organization of the Colorado League into a 501(c)(3) for the purpose of streamlining the organization. The goal was to clarify LWVCO's image with its members and the public, save volunteer and staff time and money, and increase its fundraising ability. At the 2017 LWVCO Convention, upon the recommendation of the LWVCO and the LWVCO Education Fund boards, the members voted to combine the two entities into one 501(c)(3).

At the November Board meeting of LWVDenver, the boards of both the LWVDenver and the LWVDenver Education Fund voted to recommend to its members at the 2018 Annual Meeting that we follow the lead of the State League and combine the two entities into a 501(c)(3). (Note: The LWV Education Fund Board is made up of the LWVDenver Board and the Secretary and Treasurer of the LWV Ed Fund.) As a first step toward this conversion, between now and May, an LWVDenver task force will revise the Bylaws and Articles of Incorporation of the Denver League to reflect the conversion to a single 501(c)(3) organization and present these new bylaws to the members for a vote.

Toni Larson, LWVCO President, has shared a list of the advantages of becoming a 501(c)(3) as well as a list of FAQs about the conversion. Some specific advantages in addition to those mentioned above include:

- Eliminates the need to transfer money between the two organizations (only one Treasurer needed)
- Eliminates the need to prepare two IRS forms and Secretary of State forms and payments
- Simplifies fundraising all donations and membership dues would be tax-deductible for the donor
- Allows all purchases by the organization to be tax-exempt

gone into this \$1.3 billion plan, approved by Denver

City Council August 29. There is a public-private partnership with DIA and Ferrovial Airports based in Madrid, Spain. Ferrovial will perform the reconstruction in return for control of the concessions on level 5 and a carefully structured DIA monetary payback over 34 years. DIA does not use taxpayer dollars, but is funded by airline leases and concession and passenger fees.

Our adventure was very timely as City Council had just approved the \$1.5 billion 39-gate expansion the night before. Fentress Architecture Firm originally designed the airport with a great deal of forethought so


that it could expand. The three concourses will telescope out to their full length at a construction cost that is much less than building a fourth concourse.

The airport opened in 1995 and was designed to carry 50 million passengers a year. Last year the number of passengers was 58.3 million, and this year is on track to exceed that number. The expansion plans are estimated to increase the airport capacity to 80 million annual passengers. The new flow of passenger traffic will also improve the safety of the security screening area.

Our Cheesman group had a delicious lunch at the Grill & Vine, a gourmet

restaurant at the Westin and used the A-line to return home. We thanked Cindy Sestrich heartily for planning this unique experience.

District of Columbia Statehood: New Columbia, an Opportunity to Act

The population size of Washington D.C. and Denver are quite similar. In 2016, Denver had 699,729 residents and D.C. had 681,170. Imagine, however, if Denver had no voice in the federal government or even control over the city's own laws and budget. That is what D.C. residents experience.

The citizens of the District voted overwhelmingly in November 2016, to seek statehood and then petitioned Congress to become a state: New Columbia. The bill known as the New Columbia Admission Act was introduced in both the House and the Senate in January of 2017. HB 1291 has 136 cosponsors including Colorado Representatives DeGette, Perlmutter, and Polis. The Senate Bill, SB 1278 has 19 co-sponsors, but THERE ARE NO COLORADO CO-SPONSORS!

League has long supported and worked for equal representation of D.C. in the Congress. In 1978 League supported a constitutional amendment giving voters in the District a vote in Congress. Sixteen states ratified it before its time limit occurred.

Now we can ACT AGAIN. Please support the D.C. League of Women Voters and all D.C. residents by urging Senators Michael Bennet and Cory Gardner to add their names as co-sponsors.
