Redistricting and the League

During the LWVUS 2016 convention, a position on redistricting was adopted by consensus. Here is the Redistricting Position in Brief:

Support redistricting processes and enforceable standards that promote fair and effective representation at all levels of government with maximum opportunity for public participation. (Full statement can be found at the LWVUS website.)

In fall 2016, LWVCO was asked to join a group now called Fair Districts Colorado (FDC) to bring two initiatives to the Colorado ballot - one for legislative and one for congressional redistricting (#67, #69). Four Colorado League members joined the group: Jean Fredlund, Chair of the LWVCO Redistricting Committee; Toni Larson, LWVCO President; Barbara Mattison, LWVCO Past President; and Andrea Wilkins, LWVCO Staff Lobbyist.

In December, the State Board voted to support the initiatives developed by FDC. These initiatives have had their title set and have been approved by the Supreme Court. Opposition to these measures developed and an opposing group, People Not Politicians (PNP), has filed two initiatives (#95, #96), which have their title set, but are not yet approved for circulation. FDC has met with representatives from the PNP group and have found several areas for compromise. There is also some opposition to the State League's actions by several individual League members.

We are hoping that a compromise will be introduced in the legislature to bring it directly to the ballot. If not, the State Board will ask local Leagues to circulate petitions to secure their spot on the ballot. We have been asked by the State League to inform our members of the efforts to date and will be sending updates as they become available by e-mail.

A look at Colorado Tracer (<u>tracer.sos.colorado.gov</u>) shows that FDC has received \$26,815 in contributions.

All but one range from \$10 to \$285. The exception is a contribution from Nobel Energy of \$25,000. Kent Thiry, CEO of DaVita Inc., has come on board as the FDC Chairman and is expected to further fund the organization.

Currently, the district boundaries for statehouse seats are drawn by an 11-member commission appointed by the governor, legislative leaders and the chief justice of the Colorado Supreme Court. FDC is proposing the creation of an independent commission balanced equally between Democrats, Republicans and Independents. It would also require a super-majority of commission members - including at least two of the Independent members - to approve maps. It would stipulate that only the commission's impartial, nonpartisan professional staff may draw the initial maps and would require competitive districts. It would also protect communities of interest, including minority voters and rural communities, from being manipulated for partisan reasons and require the redistricting commission to conduct its business transparently. 

Equity in Education, Colorado Style

The current word of the day in education is "equity." Some of the powers that be have finally figured out that not only is it important to have adequate funding for our public schools, it is important to meet the needs of individual students and that doesn't necessarily mean equal amounts of funding. Some kids are just more expensive to educate than others.

Our presenters for this briefing will be Dr. Kathryn Young, professor of education at Metro State University, and a representative from Great Education Colorado, a non-profit that has been working for more than a decade on improving funding for Colorado's public schools. Dr. Young will speak to the educational aspects of equity. The Great Education Colorado representative will speak to the equity issues across Colorado and will present information on the Great Schools, Thriving Communities citizen's ballot issue being proposed for the fall election.

Not only will this event provide you with the background for the need for increased equity to combat the achievement gap, as well as the general underfunding of our schools; it will provide participants with specific actions we may take to solve this problem.

Another Look at TABOR

The League of Women Voters of Denver is taking another look at the Taxpayer's Bill of Rights (TABOR). TABOR is a Colorado Constitutional Amendment passed in 1992. The three main provisions of TABOR are: (I) Mandates elections for tax or debt increases; (2) Limits on revenue, set at population growth plus rate of inflation; and (3) Prohibits certain types of taxes, including a graduated income tax or statewide property tax. Since TABOR's passage 25 years ago, Colorado's population has increased by 2 million people. Legislators have struggled to find ways to finance necessary investments in our communities, such as schools, roads, healthcare, affordable housing, and other government services. Municipalities have to go to the voters to get rid of the revenue limits, but the state does not have that option. Deferred infrastructure maintenance, reduced government services, and other issues are passed on to the next group of elected officials, who then have no choice but to pass the financing problem on to the voters. What is going to happen to our state in the next 25 years, when our state's population is expected to grow another 2 million people?

Please join us and Carol Hedges, Executive Director of the Colorado Fiscal Institute, and author of "<u>Ten Years of TABOR</u>", for an insightful presentation on TABOR and what impact it may have on Colorado's future. The Colorado Fiscal Institute is a non-partisan, non-profit, independent research organization devoted to economic and fiscal issues in Colorado. Comments from the President's Report to the Annual Meeting League of Women Voters of Denver March 24, 1954

"Because the League is an organization which not only studies but takes action, it is subject to misunderstandings. Some of these are voiced by well-meaning but uninformed people who need only the courtesy of an answer by a well-oriented member. Some of these develop from partisan individuals who do not realize how fully we encompass both Republican and Democracy [Democratic] party members - so that our stands are truly non-partisan in their reflection of majority opinion. The third type of misunderstanding is deliberately provoked by those who seek power through an emotional and unreasoning appeal. The calm factual approach of the League which leads to the well-balance activity of the individual member is a complete denial of tyranny and its methods."
