Time for Voter Service

If you're interested in helping make sure as many Denver citizens as possible are able to make their voices heard in our elections — and to make sure those voters are informed by facts — Voter Service has a job for you!

A group of interested Leaguers met January 22 to plan for this year. While we don't expect to be as busy as last year (or next!), we want to develop partnerships with other groups and sites in preparation for a busy presidential election year. We're actively looking for organizations that can help us find populations with relatively low levels of registration and participation in elections. If you have connections that may be helpful, please let us know. And of course we'll be doing registration at naturalization ceremonies and other events through the year as well. (You haven't lived until you've experienced the energy and athleticism of the B-Boy Factory!) You can contact Jeanette Scotland (jscotland@gmail.com) or Anne Duncan (anned47@msn.com) to find out how to get the required training.

We're already working with the Colorado Criminal Justice Reform Coalition (CCRJC) to register potential voters in Denver County jails. After a training session with representatives of CCJRC on January 30, we're moving on to more specialized training at the jails in preparation for a voter registration on March 6.

In addition to voter registration, we'll once again be putting together pro/con information on ballot issues. Already there are four initiatives on the May ballot, and there may well be more. Let us know if you'd like to investigate the pros and cons of an issue for the booklet we'll publish before the election.

Finally, we're already getting requests for speakers who can inform groups about the ballot issues. Contact Joan Friend (jfriendrd@gmail.com) if you'd like to learn how to do this very important job.

Denver's Health—Now and in the Future

Monday, March 4 McCollum Room 5:30 p.m. Social Time/Announcements Montview Presbyterian Church 6:00 p.m. Program Begins

We are all aware of concerns for the future of our own health, but have you seen a study of the health concerns of a broad spectrum of Denver's youth? An unusual recent study was conducted by youth through interviews with their peers. They asked about their current key issues and their concerns for what will affect the future of their health. They were also able to comment on ideas of how to mitigate their concerns through action they can take now to work towards improving their future health. The results might surprise you as their concerns are not what we were concerned about in our youth.

Abbie Steiner, Denver Public Health Epidemiologist, will present the results of this recent survey and the means by which it was conducted. The study is going to become more widespread for health assessment and for creating paths for decision-making for our future. You will get to be part of this health assessment this evening.

The second half of the evening will concentrate on a rising health concern for all ages of our Metro Denver population. A recent publication from the Colorado Health Institute, "Colorado's Climate and Colorado's Health – Examining the Connection," raises awareness of current and future health effects of climate change to our Colorado population.

Rosemary Rochford and Elizabeth Carlton are researchers from the CU Department of Immunology and Microbiology and School of Public Health. They are leading experts in the field of climate change and how it relates to health effects from our changing environment. They made a major contribution to the Colorado publication.

Come and learn what factors are in our control for the future of our health and how to increase awareness. We have all heard the warnings; now take the opportunity to identify collectively and individually how we might change our future healthcare path.

Both the youth study and the Colorado climate/health publication will be posted on the hwydenver.org website to coordinate with the briefing.

Implementation has begun!

At the LWVD's Annual Meeting in 2018, we approved a budget expenditure to improve the LWVD office technology. Pledges at the meeting raised the needed funds and we have begun implementation. After a search process conducted in parallel with LWVCO, LWVD has chosen to implement an association management system called Club Express. This system will help us with several of our strategic goals including improving internal and external communication, helping individuals to join LWVD more easily, and making our activities and accomplishments more visible to LWVCO.

Several other local leagues in Colorado have already implemented the system, and we will be joining them and the State office in a common system once our implementation is complete. The target date for completion of the project is August 2019. In the meantime we will be keeping you informed of the improvements you are likely to see and how you "fit in" to the new system.

A Goal for 2020

In September 2016, the LWVD launched the Future Fund with the purpose of creating a plan for financial security and sustainability. The goal was to raise \$100,000 by 2020. Presently the fund has raised \$58,000. Thank you to all members who have contributed and fulfilled their pledges. However, more contributions will be needed to reach our goal. Stock contribution transfers are being handled through Fidelity Brokerage Services. All contributions are tax deductible. Beginning in 2020, the Board can use 10% of the funds each year for expenses. Presently, the LWVD is financially stable and will not need to draw on these funds. The Board is comfortable in knowing we have a cushion should it be needed.
