Redistricting Update

The League of Women Voters of Colorado, as part of a bipartisan coalition (Fair Districts Colorado) is taking action on redistricting reform with the filing of initiatives for the 2018 ballot. The initiatives work to ensure democracy and fair representation in Colorado by establishing an independent commission to draw fair state legislature and congressional district lines.

As we have mentioned before, on March 22, two initiatives were agreed upon by Fair Districts Colorado and People Not Politicians. They were filed with the Secretary of State office and both are awaiting an initial hearing. Read them here: #170 and #171. (Hint: They are almost identical, except for some legalese, numbering of the sections, etc.)

The 71st general assembly will adjourn on May 9. According to leg.colorado.gov, there has been a lot of interest in bills that would modify PERA, address concealed handgun carry with no permit, and repeal the ammunition magazine prohibition. Our League lobbyists have been hard at work all session following bills and advocating for League positions. They have been paying particular attention to the gun-related bills in light of the #MarchforOurLives movement.

This always well-received and interesting briefing will bring us a review of the session with an emphasis on League issues and the bills we supported or opposed.

Important Business for Annual Meeting

League of Women Voters groups across the country have traditionally been designated 501(c)(4)s by the IRS, meaning that they were potentially lobbying groups, attempting to influence legislation. They were still nonprofits, but not tax exempt. That is why the national, state, and some local Leagues, including Denver, formed Education Funds, which were strictly educational and therefore earned 501(c)(3) status and could accept tax deductible donations. However, the IRS has now redefined the definition of a 501(c)(3) and is measuring "substantial" lobbying by amount of money spent. The Denver League would be allowed to use up to 20% of its total expenditures towards lobbying. In the past that actual expenditure has been much smaller. Since League lobbying is almost solely by volunteers with only a small portion of budgets spent on attempting to influence legislation (and virtually none in Denver), we now qualify for 501 (c)(3) status. Leagues across the country are making this change. LWVCO and Boulder County are just two examples.

The LWVD Board recommended we make this change and several Denver Leaguers have been working hard to accomplish this conversion to a single organization. The decision must be made by a two-thirds majority at Annual Meeting. Included in this *Voter* are proposed amendments to both our Articles of Incorporation and our Bylaws. Bobbie Heisterkamp will explain the process and changes at Annual Meeting, but we recommend that you look over these documents and bring your questions to Annual Meeting.

Toni Larson, LWVCO President, has shared a list of the advantages of becoming a 501(c)(3):

- Eliminates the need to transfer money between the two organizations (only one treasurer needed)
- Eliminates the need to prepare two IRS forms and Secretary of State forms and payments
- Simplifies fundraising—all donations and membership dues would be tax-deductible
- Allows all purchases by the organization to be tax-exempt

This decision is important to the future of the League of Women Voters of Denver. We encourage you to get informed and support this process.

US League Sends Letter to U.S. Senate on Need to Reduce Gun Violence

The League sent a letter on March 22 to the U.S. Senate outlining the policies needed to curb gun violence. The League believes it is time for Congress to adopt legislation that will close the gun show loophole, increase penalties for straw purchases of guns, ban assault weapons, place limits on high capacity ammunition magazine size, and fund research and reporting on gun violence in America.
