# Future Fund Closing in on \$50,000 With a \$10,000 Matching Pledge

We just celebrated 85 years of the LWVD with a gala event at the Brown Palace. Now we must look forward and begin the second year of the Future Fund. The Fund was created to give our League financial security and sustainability. The interest on the money raised for the Future Fund will be used to support new and expanded education programs for the Denver League and to fill in gaps in operational funding. In September 2016, the Development Committee set a goal of \$100,000 to be reached by 2020. We should not need any of the money prior to that date.

Currently, 45 members have contributed or pledged

\$35,000. Two long-time members have created a matching challenge with a December 31, 2017 deadline. They each have pledged \$5,000 for a total of \$10,000, which will match, dollar for dollar, any new contributions received by the end of 2017. All contributions are tax deductible. With this matching challenge and our farsighted and generous members we think we can reach the \$50,000 goal.

It's also time for those of you who made pledges covering a 3-5 year period to send this year's pledge if you haven't already.

Speaking of farsighted, our committee would like to extend our reach outside



#### What if You Couldn't Vote?

We are pleased to welcome Anne Anderson, a Leaguer from Washington, D.C. and Chair of the LWVDC Committee for Full Rights for DC Citizens, who will inform us about those American citizens who cannot vote. LWVDC received a grant to travel to Leagues around the country to present their case advocating for voting rights for Washington, D.C., a position that the League has had since 1982. She will also discuss Puerto Rico and the other inhabited territories of the United States. Many Americans don't even know that residents of the five inhabited territories of the United States—like Puerto Rico, which has a population larger than 21 states—are American citizens, but lack the full representation provided to those who live in the states. Washington, D.C. citizens could not vote for anything until the late 1950s and their one representative has no vote on the house floor of Congress. There is no representation in the Senate. Anne will have handouts and a map of how the new state and the new District of Columbia would look. We welcome this opportunity to learn about the disenfranchisement of our fellow citizens and to offer hospitality to a fellow Leaguer.

We hope to have a good turnout, and for the occasion we will extend the social time and offer a variety of appetizers as well as a glass of wine if you are so inclined. So come at 5:30 p.m. to enjoy this special time and we will start the program when it seems appropriate.

#### The Charm of Green Roofs

The ballot initiative requiring building contractors to install green roofs in buildings with 25,000 or more square feet of roof space, whether it is approved by the voters or not, has brought to the public's attention what at first seems like a luxury item for the wealthy but is actually an affordable pleasure for people in all walks of life, especially people who work or live in tall buildings.

NOTE:

The technology for installing roof gardens has been proven to extend the life of a roof for many years. More immediately economical, however, is the drop in heat-

ing and cooling costs. Then, too, green roofs offer a respite for office workers or renters where the air is refreshingly far from the congested streets below. Green gardens capture storm runoff that otherwise swirls into the sewer system carrying the toxic materials that litter city streets. And last, but perhaps one of the

greatest benefits, is the reduction of carbon dioxide spewing into the air, contributing to global warming.

Numerous studies over the past ten to fifteen years have validated claims for the cost effectiveness of green roofs in urban areas. A report from EPA Region 8 features excellent pictures

of green roofs in our arid western region, including the green roofs at the Botanic Gardens and the REI building. As green roofs, hopefully, become more prevalent in Denver, whether as a

result of voters' decisions, tax breaks or other incentives, or just wise decisions on the part of builders and building owners, it will be yet another milestone in the development of a truly livable city.
