#### The Fall Election Season Begins

Denver faces a Coordinated Election on Tuesday, November 7, 2017. It seems quite a ways off, but mail ballots will drop the week of October 16. I have used the language "coordinated election" for years, but decided perhaps I should look up what that really means. I'm sure our League readers know, but in case . . .

"A coordinated election is defined by law as an election where more than one political subdivision with overlapping boundaries or the same electors holds an election on the same day, and the County Clerk and Recorder is the coordinated election official for the political subdivisions. (See C.R.S. § 1-1-104 (6.5)) This means there may be local or state initiatives or referenda on the same ballot containing candidates for School District Director." (Source - Denver Election Division)

And we will have local ballot issues and the school board candidates on the ballot in November.

There are four Denver Public School board seats up for election in November—At-large, District 2, District 3 and District 4. All current seated board members are eligible to run, though Rosemary Rodriguez has announced that she will not seek re-election. As of this writing, it looks like all four seats will have at least two candidates running. Petitions began circulating on August 9, but are not due to the Secretary of State's office until September 1. Petitions must be signed by at least fifty (50) eligible electors from throughout the school district.

There will be no state ballot issues, but we anticipate possibly four local issues. First, the City and County of Denver has proposed a General Obligation Bond ballot issue (GO Bond) meant to provide funding to restore, replace, and expand infrastructure and capital assets across the city. It is based on Elevate 2020, the 2015-2020 Six-Year Capital Improvement Plan (CIP). It will be divided into seven separate questions by category.

There are three other potential issues on the ballot. A Democracy for the People initiative is a citizen-initiated ordinance that promises to reform and modernize elec-

tions in Denver. The Denver Green Roof Initiative would require gardens atop most new buildings of at least 25,000 square feet. And finally, an initiative to amend the city charter to change the name of the Dept. of Environmental Health to the Dept. of Public Health and Environment and to increase the size of its board may make the ballot.

As part of the Denver Decides consortium, we will participate in four candidate forums and one Ballot Issues Forum. They will be held at the Channel 8 studio, streamed live on-line and available on the Channel 8 website.




Q: Why do we want to have a public dialogue with Secretary of State Wayne Williams?

#### **Advocacy**

At the August board meeting, LWVD voted to support the Denver GO bond initiative and to add our name to the Colorado Education Network, a group working on increasing funding for public schools, the latter at the suggestion of Leaguer Sally Augden.

The board also discussed Democracy for the People, a citizen initiated ordinance that is currently collecting petition signatures. This effort is being led by Clean Slate Now, an organization founded by former state Senate Majority Leader Ken Gordon and now led by Jon Biggerstaff, who recently ran for Senate District 33. Boulder County Leaguer Shirley Jin strongly urged the Denver League to support it, saying "The initiative does meet the LWVUS position on money in politics. It will increase transparency and set up a small-donation-matching program. It will prohibit candidates from accepting contributions directly from

corporations, require thorough disclosure of money spent on behalf of or against a candidate (commonly called dark money), and reduce contribution limits that are uncommonly high compared to state elections." Denver Leaguer Toni Larson represented the League in a larger group of organizations that was considering a similar initiative. She also feels we should support this measure.

The Board, however, had some concerns and decided to table discussion of supporting the initiative until it was certain to be on the ballot. Concerns included:

- Is there enough organizational and financial support?
- Would next election season be a better time?
- Does Denver really need this initiative as the election process is run well now?
- What about money in school board elections, which is not addressed in this initiative?

#### **Ballot Title**

Shall the voters of the City and County of Denver adopt an amendment to the Denver Revised Municipal Code requiring disclosure of independent spending and electioneering, requiring political advertisements to identify who paid for them, banning corporations, labor unions and other entities from donating directly to candidates, and lowering contribution limits; and adopting a new Article VIII to Chapter 15 of the Denver Revised Municipal Code creating a dedicated fund within the City's general fund, capped at 8 million dollars per 4-year election cycle, as appropriated by City Council and Mayor to match donations of 50 dollars or less at a ratio of 9 to 1 to candidates who voluntarily agree to raise money in lower amounts and do not take contributions from political committees?
